

NARRATIVE

This survey was performed at the request of Ken Lewis for the purpose of subdividing the property described on that Warranty Deed recorded on page 359, Book 4111 of Deeds in the County Recorder's office. The description on the deed has a misclosure of 99 feet in the North-South dimensions. An examination of the surrounding deeds revealed that the error was in the West lines. A search of records showed that the Bureau of Land Management resurveyed Section 31 in 2005 during which several aliquot part corners were set. A field search was made for these monuments and the results are noted on the plat. These monuments were used to control the survey and the property was divided as platted.
