


PROPERTY SURVEY FOR

BEARINGS ARE BASED ON WGS84 DATUM.


◆ INDICATES 5/8"X24" REBAR SET BY THIS SURVEY

NARRATIVE

THIS SURVEY WAS PERFORMED TO MONUMENT THE PROPERTY CORNERS OF SEVERAL PARCELS IN THE NE 1/4 OF SECTION 3, T4S, R6W, U.S.B.&M.. THE UNITED STATES BUREAU OF RECLAMATION (US BOR) HAD PERFORMED A SURVEY OF THIS SECTION IN 1966 TO DETERMINE THE BOUNDARY OF THE GOVERNMENT "TAKE LINE" AROUND STARVATION RESERVOIR. SEVERAL OF THE CORNERS THAT WERE FOUND OR SET AS PART OF THAT SURVEY WERE FOUND AND USED AS REFERENCES FOR THIS SURVEY. THE US BOR SURVEY PLAT SHOWS THAT THE NORTH QUARTER CORNER WAS FOUND AND USED AS PART OF THE US BOR SECTION BREAKDOWN. THIS SURVEY COULD FIND NO EVIDENCE OF THE CORNER FOUND BY THE US BOR. HOWEVER AN ORIGINAL BEARING TREE AND COUNTY MONUMENT WERE FOUND AT THIS QUARTER CORNER. THIS POSITION IS DIFFERENT THAN THAT INDICATED BY THE US BOR PLAT. ALSO, THE US BOR PLAT INDICATES THAT THE WEST QUARTER CORNER WAS NOT FOUND. THIS SURVEY FOUND THE ORIGINAL MARKED STONE AT THIS CORNER. USING THESE TWO QUARTER CORNERS ALONG WITH THE TIES TO THE OTHER CORNERS AS SHOWN ON THE US BOR PLAT THE SECTION WAS PROTRACTED AS SHOWN.


SURVEYOR'S CERTIFICATE
