Roosevelt Library Next Steps Discussion

- Babcock Design Feasibility Study/Discussion
- Remodel or new construction? Discussion of pros/cons of each
- We need to ask Sam Passey from Vernal about how the flat roof in Vernal is holding up/draining
- Discussion of the new construction—eye line from the Information Desk is much better than the remodel option
- Less staff needed with new construction because of how open the floor plan is—which
 potentially would cost less in the long-run than remodeling
- Funding—would we potentially have to raise the taxes by a small amount in order to pay for this building and its staffing?

Library Revenues & Budget Shortfalls

- 2.7 million reserve for the library already saved, but we are going to drain it.
- Staffing—probably will need 25 to 50% increase in staff, which is about \$100,000 a year
- The new building would possibly (floor-plan wise) be more economical in the long run, but we will need to hire some more staff.
- Perhaps Roosevelt could help with the Utility bills for the new library
- Library tax. Tax is .000286 (certified for the whole state without having to go through Truth in Taxation) of your property value. Average home (\$165,000) pays \$26 a year to the library. What if it was increased to .00037? On the average, just under \$8 increase per year.
- Truth in Taxation takes a year and you need a minimum of 3 public hearings where you are scrutinized highly. We have to put out pamphlets, be very clear and transparent as to why this is needed. It ultimately comes down to board meeting. If board members all approve, it will go through.
- We will need to rebuild the capital project nest egg.
- Page 41-42 of feasibility study—low cost and high cost for renovation is 2.2 to 3 million dollars. Low cost and high cost for new build is 2.9-3.7 million. We already have 2.7 million saved towards it. Does not include the land, but hopefully Roosevelt can help with that.
- People need to be aware of what is available now through the library. Ebooks, interlibrary loan, activities, movies, clubs and gatherings.
