Consideration For Adoption Of Resolution No. 10-20, A Resolution Of The Board Of County Commissioners Of Duchesne County, Utah, Authorizing The Issuance And Sale of Its Hospital Development Revenue And Refunding Bonds (Uintah Basin Medical Center Project), Series 2010 In Aggregate Principal Amount Of Not To Exceed \$22,400,000; And Related Matters

Mr. Hales stated that we have discussed in the past retiring CIB funds received in 2007 in connection with the long term care facility that was built at that time. There was a nine million dollar (\$9,000,000.00) tax exempt bond and a five million dollar (\$5,000,000.00) CIB bond that helped to build it at that time. Back in February we refinanced the tax exempt nine million dollars (\$9,000,000.00) along with the taxable five million dollars (\$5,000,000.00) for the OMB medical office #2. It would be prudent to retire the debt along with the CIB; and at the same time save some interest cost with the interest rates dropping. There are federal incentives to get this in place by the end of the year. Commissioner Winterton stated that this is not new money; it is existing money.

Commissioner Winterton motioned to approve the Resolution No. 10-20, Commissioner Peatross seconded the motion. Both commissioners voted aye and the motion passed.

Consideration Of The Minutes For Working Commission Meeting Held December 6, 2010 Commissioner Winterton motioned to approve the minutes as presented. Chairman Peatross seconded the motion. Both commissioners voted are and the motion passed.
