CERTIFICATION OF BUDGET

DUCHESNE COUNTY

Calendar Year Ending December 31, 2011

ADOPTION OF BUDGET INFORMATION:

In compliance with Title 17, Chapter 36, Section 15, Utah Code, which states:

“On or before the last day of each fiscal period, the governing body by resolution shall
adopt the budget which, subject to further amendment, shall thereafter be in effect for
the next fiscal year. A copy of the final budget, and of any subsequent amendment
thereof, shall be certified by the budget officer and filed with the state auditor not later
than thirty days after its adoption. A copy, similarly certified, shall be filed in the
office of the budget officer for inspection by the public during business hours.”

WHEREAS the legislature of the State of Utah has granted legislation providing for
the adoption of said county annual budgets and;

WHEREAS there exists a need to utilize this provision of the State statutes to serve the
best interest of the County and the residents thereof and to promote the most efficient
and practical operation of county government. The purpose of this resolution is to
adopt the 2011 Duchesne County Budget by revenue and expenses;

NOW THEREFORE, be it hereby resolved as follows;

Consideration Of Resolution No. 10-22, A Resolution Increasing Revenue And Expense for 2010 In the General Fund

Clerk/Auditor Freston stated that we discussed this in the public hearing. She will increase the budget by five hundred fifty thousand dollars (\$550,000.00) to cover the expense of the Strawberry River cleanup project; she will also move thirty two thousand dollars (\$32,000.00) into fund 23, a dedicated fund to the public lands fund to cover the cost of some equipment. Chairman Peatross stated that we are opening up the 2010 budget. Clerk/Auditor Freston stated that we have to increase the revenue to match the expense so that we can balance the budget.

DUCHESNE COUNTY RESOLUTION 10-22

WHEREAS the legislature of the State of Utah has granted legislation providing for the **increase** in unencumbered or unexpended appropriations from one department to another within the same fund, the said legislation being designated as Section 17-36-26 of the Utah Code annotated, 1953, and amended 1975; and

WHEREAS there exists a need to utilize this provision of the State statutes to serve the best interest of the County and the residents thereof and to promote the most efficient and practical operation of county government. The purpose of this resolution is to increase the 2009 Duchesne County Budget by revenue and expenses and free up said monies spent;

NOW THEREFORE, be it hereby resolved as follows;

RESOLUTION NO. 10-23

A RESOLUTION ESTABLISHING A NEW FEE SCHEDULE FOR BUILDINGS AND CONSTRUCTION WITHIN DUCHESNE COUNTY

WHEREAS, Duchesne County Code Title 7 establishes rules and regulations for buildings and construction with Duchesne County; and

WHEREAS, Duchesne County Code §7-1E-2 authorizes the county to establish permit fees for building and construction; and

WHEREAS, said code also authorizes the fees to be set by resolution; and

WHEREAS, Duchesne County desires to amend said fees commencing January 1, 2011.

NOW, THEREFORE, be it resolved by the Board of County Commissioners for Duchesne County that the fee schedule for the Duchesne County building and construction enforcement in Exhibit A attached hereto and hereby incorporated by reference, is adopted.

IT IS FURTHER RESOLVED that the method used to calculate the fees on the individual projects shall be that as set forth in Exhibit B attached hereto and hereby incorporated by reference.

IT IS FURTHER RESOLVED that an existing fee amounts contrary to this resolution are changed to reflect this new fee schedule, and that this fee schedule shall be effective January 1, 2011.
