Report From The Uintah Basin Medical Center (UBMC)

Mr. LeBaron presented the attached report and stated that we appreciate of the members roll in giving us a great board. We now have close to seven hundred fifty (750) employees affiliated with UBMC and Uintah Basin Healthcare. We now have a surgeon available twenty four hours a day, which is a milestone. We have smaller projects going on and annually renovate 7,000 to 8,000 square feet.

Mr. Hales presented the attached audit report and stated that the opinion letter from the accountants stated that UBMC financial position of its activities and its cash flows ended with conformity with accounting principles generally accepted in the United States of America. We wrote off in charity care one million sixteen thousand dollars (\$1,016,000) and wrote off five million dollars (\$5,000,000) in bad debt.

Mr. Snow stated that he appreciates the commissions trust in the board members and feels that the hospital serves the community well with an excellent staff.

Review And Potentially Award Bids For Construction Of The Duchesne County Emergency Watershed Protection Flood Rehabilitation

Commissioner Winterton stated that we need to postpone this again as we are not ready.

Consideration Of An Agreement Between Green River Energy Resources And Duchesne County For Law Enforcement Services

Sheriff Mitchell stated that Green River Energy Resources is doing seismograph work in Duchesne County and has had issues with landowners. Green River Energy Resources has requested to pay officers to come and keep the peace. Commissioner Peatross motioned to approve the agreement with Green River Energy Resources as recommended by the Sheriff's Department. Commissioner Winterton seconded the motion. Both commissioners voted aye and the motion passed.
