Consideration Of Payment Vouchers

The commission reviewed vouchers # 123686 through 123750 dated November 21, 2012, in the amount of three hundred fifty thousand one hundred fifty six dollars and ten cents (\$350,156.10) as presented by Auditor Freston. Commissioner Winterton motioned to approve the vouchers as presented by the Clerk Auditor's Office. Commissioner Peatross seconded the motion. All commissioners voted aye and the motion passed.

Tax Adjustments – Auditor

The commission reviewed the attached tax deferrals presented by the Clerk/Auditor's Office. Commissioner Peatross motioned to approve the tax deferrals as recommended by the Auditor's Office. Commissioner Winterton seconded the motion. All commissioners voted aye and the motion passed.

Consideration Of A Business License Application For Lazy C Trucking Inc.

Consideration Of A Commercial Lease Agreement With Cedarview-Montwell Special Service District

Attorney Doherty stated that we are waiting for proof of liability coverage. They are going to make application for coverage from UCIP under us. Commissioner Winterton stated that he has a problem with paying for their internet that is a part of the contract. Chairman Wood stated that we need to ask the IS Department if this is unlimited access where it doesn't affect us or if we are limited in any way and this is an added bill. Attorney Doherty stated that we can change the agreement if that's what needs to be done. Commissioner Peatross motioned to approve the agreement with Cedarview-Montwell Special Service District subject to attorney review and appropriate insurance in place; however, as a caveat we will allow them to move their equipment into the office space without them taking occupancy. Commissioner Winterton seconded the motion. All commissioners voted aye and the motion passed.
